- The books must be supplied within 30 days, failing which the order will be treated as cancelled.
- Only latest editions of books are to be supplied except mentioned, otherwise, the price charged must be according to Publishers catalogue.
- The bill should be accompanied with price proof wherever the price is not printed on the book.
- 7. The following certificates/essential numbers shall be recorded on the bill
 - a. PAN/TAN Number of the Firm/Agency

 - c. Approved discount is applied on the purchase order.
